Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on **13:00 Hrs of 2 March 2025** at the Pakhribas Municipality, Office of the Municipal Executive, Dhankuta, Koshi Province, Nepal. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
